Recording Artist “JW Feel Good”

This rider has been prepared to enable Recording Artist “JW Feel Good” to give his best performance and should be adhered to. Any revisions you wish to make must be confirmed in writing 48 hrs prior to performance. All Rates are subject to change dependent on travel & hotel incidentals provided by the talent purchaser. All audio equipment is required with no equipment upgrades with out the written approval of the house engineer and or artist. Not providing the proper equipment on the date’s booked can result in a breach of contract and have serious sound problems and legal proceedings.

Enclosed are two copies of the rider any attachments are binding parts of this agreement. Please initial each page and return one copy with original signatures and any certified cashiers checks as required to below address

Artist Management

1}. In the event that “JW Feel Good” is the headliner, “JW Feel Good” shall have the absolute rights of approval of all acts on the show unless other wise noted in the addendum of this agreement. “JW feel Good” shall have the absolute right of approval of set length of other’s artist’s performances.

2}. “JW Feel Good” shall have absolute right of approval of placement of all his equipment on stage and use of the theatrical effects, sound and lighting etc. In the event “JW feel Good” is the headliner no equipment will be struck from the stage after the initial sound check without prior approval from “JW feel Good”.

{NOTE} ONLY “JW Feel Good” sound engineer can authorize extended sound checks, announcements, extended sets or theatrical effects of any kind for support act.

3}. BILLING: IF “JW FEEL GOOD” is headlining, they shall receive 100% sole headline billing on all marquee and paid advertising and shall close show at each performance during engagements hereunder. If JW Feel Good is being paid on percentage basis Talent purchaser/Club owner agrees to give to JW feel good seating

printers manifest of the house from the printer of tickets, listing the amount of tickets printed at each price if the show is a SOLD OUT all compensation shall be based upon this fact. Cost of the actual show is as follows:

- Ø All Food Catering during sound check, free soft drinks to band
 - Ø Talent Purchaser/Club Owner provides adequate dressing bathrooms
 - Ø Talent purchaser/Club Owner provides all Sound & Lights
 - Ø Talent Purchaser/Club Owner to provide all security for equipment
 - Ø Club Owner to provide all security & parking for guests
 - Ø Talent Purchaser/Club Owner to also provide 5 complimentary tickets to “JW”
 - Ø Talent purchaser to provide table and chair for adequate space for merchandising sales
 - Ø IF JW is headliner talent purchaser/club owner agrees that no more than 1% of tickets shall be distributed as complimentary.
- a). If “JW Feel Good” is support act shall receive” Special Guest Star billing which shall encompass 75% of the type of size of the headliner Artists billing relating to advertising and marquee shall be at least 25% smaller that the headliner.
- b). “JW Feel Good” shall sell all his cd’s, t-shirts, and merchandising for his own profit. This is also the subject of this agreement.

c). All moneys agreed shall be in paid 50% good faith money deposit 30days prior per contract and the balance during the end of show or before.

4). Only Talent purchaser employees are allowed back stage during sound checks and actual show. Only individuals with proper identification will be allowed access. JW May request special lighting and audio and full power of the PA system. Purchaser agrees to provide security for "JW feel Good" equipment at all times. If any equipment of "JW Feel Good" is misplaced broken or damage the Talent purchaser agrees by this agreement to replace up to _____%of the physical damages.

5). All the provisions of this Contract and this rider and its attachments thereto are of the essence and failure of purchaser to comply with any of and all them shall constitute a material breach of agreement between "JW Feel Good" And the Talent Purchaser/Club Owner.

6). Any Additional Problems, act of god, bad weather, riots, terrorism threats, patron club disturbances, anything beyond the control of "JW FEEL GOOD" that may be incurred with compliance of these provisions shall be discussed with artist's manager in the first instance, prior to the day of the show. Failure to fulfill any provisions written hereof shall be a breach of contract, which may result in "JW Feel Good" Entire Performance and the deposit will be non-refundable at the option of the "JW Feel Good". Talent Purchaser/Club Owner financial obligation to JW Feel Good shall not be negated by such action. Meaning Artist "JW Feel Good" will be expecting balance immediately after scheduled performance, unless its power outage, however artist will still expect final payment.
